The peer advisor role is a paid ISA board position, because of the extra work required during the summer months – amount conditional upon performance. As a member of the board, a peer advisor is also expected to adhere to all of the requirements of the elected positions in addition to their "paid" responsibilities.

Peer Advisor Requirements:

- Corresponds with enrolled first-year students via email throughout the spring and summer answering questions or consulting International Student Advisor as needed.
- Coordinates and assists with first-year and exchange student pick-ups during Orientation and/or meets with first-year students who make their own travel arrangements to Lafayette.
- Assists ISA Advisor with arranging schedule of events for ISA Orientation throughout the summer and upon arrival on campus
- Assists new students as needed once here (i.e. with meals, paperwork, tours, free time fun events, scavenger hunt, door decorations).
- Organizes and guides a Social Security and/or Tax Identification trip downtown a few weeks into school.
- Maintains contact with his/her assigned group of first-year students throughout the academic year and assists them with any needs. Done via phone calls, email and one-on-one and group meetings. Must provide regular updates to ISA Advisor.
- Assists with/attends events designed primarily for first-year students.
- Assists with January transfer pick-ups and maintains communication with January transfer students prior to arrival at Lafayette and once here.
- Assists the Admissions office with "Email buddies" during the spring semester.
- Cannot be a Resident Advisor, Peer Counselor, or Orientation Leader during the fall term.
- Cannot study abroad during the two semesters of the position.
- Must arrive on campus the Friday prior to the start of the ISA Orientation 08/16/13
