Town and Gown: Higher Education and Democratic Engagement (under consideration). U.S. colleges and universities have a historic mission to support American democracy, which is beset with difficulties. This book illuminates a pathway for colleges and universities to follow in order to fulfill their mission to strengthen democracy. Specifically, the book identifies educational practices that support and encourage students to engage democratically, which go beyond the important but minimal duties of voting and volunteering. Democratic engagement refers to activities of greater civic commitment and potential for enacting change: the work of elected or appointed government officials, government agency employees, lobbyists, activists, organizers, policy experts, foundation officials, and investigative journalists. To arrive at educational practices that support democratic engagement, this book relies on the reflections of college-educated adults who are contributing to political life. These individuals express how their undergraduate experiences furthered their interest in democratic engagement and equipped them with useful knowledge, skills, and attitudes. They also say what they found missing. From this evidence, the book sets forth educational practices that will allow colleges and universities to fulfill more clearly their democratic purpose.
